Sub: Engagement of 50 Resource Teachers on Contract Basis in Inclusive Education under SSA, Delhi.

Applications are invited for engagement of 50 Resource Teachers (Special Education Teachers) in inclusive education under SSA. The appointment will be purely on temporary and contractual basis for a period of 5 months only on a fixed monthly remuneration of rupees 9500/- (nine thousand five thousand only).

The number of Resource Teachers proposed to be appointed for different categories of Disabled children is as follows:

Visually Impaired	=09
Hearing Impaired	=15
Mentally Retarded	=26
Total	=50

The eligible and desirous candidates fulfilling all the requirements should send their application through Registered Post/Speed Post only duly filled in the prescribed format as given below along with attested copies of certificates and documents in support of educational qualification and age to the, '**OFFICE OF THE UEE MISSION, DEPARTMENT OF EDUCATION, DISTRICT – NORTH, 1st FLOOR, LUCKNOW ROAD, NEAR ESTATE BRANCH, DELHI 110054.** so as to reach on or before 06/01/09 by 05.00 P.M. The envelop should be super scribed with "APPLICATION FOR THE POST OF RESOURCE TEACHER IN INCLUSIVE EDUCATION UNDER SSA" on the left side. Candidates seeking reservation under the reserved category should submit a photocopy of the caste certificate issued from GNCT with the application form, issued by competent authority on or before the last date of submission of application form. Candidates belonging to Physically Handicapped category should also submit the requisite certificate along with application form in support of the claim. The short listed candidates will be called for interview.

Essential Qualifications:

- i) Graduate in arts or science according to nature of vacancies with not less than 45% marks in aggregate from a recognized University (condition of 45% marks relax-able in case of candidates who possess a post graduate degree in one of the subjects related to the post and Scheduled Caste/ Scheduled Tribe Candidates.
- ii) Recognized Degree/Diploma in Teaching or Equivalent with a specialized training in the field.

Or

- Degree /Diploma in Teaching in the field concerned of a duration of not less than one academic year from a recognized Institution.
- iii) Knowledge of Hindi

Desirable Qualification: Experience of Teaching Disabled Children

Age Limit: -Below 30yrs' for male and 40 yrs for female candidates as on 06/01/2009 with an age relaxation of 05 yrs' for persons belonging to SC/ST and 03 yrs for OBC.

Reservation: Out of 50posts 24 are reserved including SC=7, ST=3, PH=1, OBC=13

Note:-

1. The candidate will be appointed purely on contract basis and will have not claim for regular appointment in the UEE Mission or Directorate of Education
2. The candidate so engaged on contract basis shall not file any court case regarding salary and regularization
3. The selected candidates will have to sign a contract agreement with SPD and in case of breach of contract, the contract will be cancelled and no notice will be given and the services will be terminated
4. Number of vacancies can be altered
5. Reservation for SC/ST/OBC will be provided as per prevailing rules
6. Selected candidates will have to join duty immediately after getting the engagement letter and in case of non joining during the stipulated period next candidate available in the merit list will be engaged or given the offer to work on contract basis and no formal intimation or letter will be sent to selected candidate in this regard.
7. The Resource Teachers will be required to attend to CWSN in any of the schools assigned to them in Directorate of Education & Education Departments of MCD, NDMC & DCB.
8. The post are itinerant in nature and the incumbents will be required to travel to various schools for attending to the needs of CWSN. No TA/DA will be paid to them for this purpose.
9. The Resource Teachers may be assigned to work any where in Delhi and no representation will be entertained in this regard.

10. Relaxation in age limit will be available as per rules to reserve categories SC/ST/OBC
11. Application with incomplete/wrong particulars or not in the prescribed format will entail rejection
12. UEE Mission will not be responsible for any delay in postage. No application will be taken after the cutoff date and time in any case.

14. No TA/DA will be provided for attending the interview.
